### **Minutes**

#### Primary Care

- Discussions over Primary Care throughout East Berkshire. What can we do and how to support.
- Communications to patients: How can we support communication to patients, to explain the process of how to access services.
- General discussions in GP websites/telephone systems. Could we involve the HW Hub in an East Berkshire review.
- RBWM is piloting a scheme to have "Community information Lead" to pass on information within the community regarding all information in health and social care/support and providers. This information is

received in a booklet, produced by the LA. Could this be done in each location.

 Discussed doing focus Groups/Interviews with targeted community groups, across all three patches, to ask questions around, GP Access, Dentistry, Mental Health and Urgent Care. Targeted groups suggested were within the refugee communities. This incorporates the main themes found from the What Matters Most reports.

#### **Dentistry**

- Write report for the Big Health Chat, which HW are currently doing in East Berkshire for June/July.
- Staff annual leave occurs in this month.
- Prepare and identify Folic Acid project and focus groups in Slough.

#### **September**

- Train both DO and JF with Enter and View Trainnning.
- Agree date for first E&V and do the necessary paperwork.

• Start to look at identifying focus groups for interviews, with in the refugee communities across locations.
